WHAT IS ASK?

ASK is a self-assessment package which is designed to help GST-registered businesses effectively manage their compliance.

It focuses on 3 key aspects:

Use of pre-filing checklist to ensure correct GST returns before submission, Annual review of past GST returns for early detection of errors (as companies may be penalised up to 200% of tax undercharged for the submission of incorrect GST returns).

IS ASK COMPULSORY?

Conducting ASK is compulsory if you are **applying** for any of the following GST Schemes:

- Major Exporter Scheme (MES)
- Import GST Deferment Scheme (IGDS)
- Approved Marine Customer Scheme (AMCS)
- Approved Contract Manufacturer and Trader (ACMT) Scheme
- Approved Refiner and Consolidator Scheme (ARCS)
- Approved Import GST Suspension Scheme (AISS), or
- Specialised Warehouse Scheme (SWS)

If you are **renewing** any of the following GST schemes:

- Major Exporter Scheme (MES)
- Import GST Deferment Scheme (IGDS),
- Approved Contract Manufacturer and Trader (ACMT) Scheme, or
- Specialised Warehouse Scheme (SWS)

Effective 1 January 2013, the ASK declaration form needs to be signed by an Accredited Tax Practitioner (GST) or Accredited Tax Advisor (GST) with the Singapore Institute of Accredited Tax Professionals.
